## Important (Please read the following notes carefully before completing this application form):

- 1. This form is to be completed by applicants applying for the SJI Philanthropic Fund-Christ's College Cambridge Scholarship for entry as undergraduates to Christ's College in 2022.
- 2. Applicants have to fulfill the following criteria to be eligible for the Scholarship:
  - a) the Scholarship is only open to Singaporeans and Singapore permanent residents;
  - b) the applicant must have completed the IB Programme at an SJI School prior to the January following application, with at least 2 years of schooling at either of the SJI Schools:
  - the applicant must apply directly to Christ's College;
  - d) an applicant who has received an offer from another college in Cambridge will not be eligible for the Scholarship;
  - e) unless otherwise agreed to by the Selection Committee, an applicant who has already accepted a scholarship of comparable or greater value from any other organization will not be eligible for the Scholarship;
  - f) an applicant who has applied for a second undergraduate programme or is already pursuing an undergraduate programme at Christ's College will not be eligible for the Scholarship; and
  - g) the applicant must be in a satisfactory state of health.
- The Scholarship is tenable for the following Triposes offered at Christ's College:
  - a) Computer Science;
  - b) Economics;
  - c) Engineering;
  - d) Natural Sciences; or
  - e) Law.
- 4. In addition to the courses listed above, Scholarship holders are permitted to choose any of the following Triposes after Part I of another Tripos:
  - a) Chemical Engineering;
  - b) Management Studies; or
  - c) Manufacturing Engineering.

For the avoidance of doubt, Management Studies can be taken either as a third-year or as a fourth-year course. However, the Scholarship will only support it as a third-year course.

- 5. Scholarship holders who change subject to one not listed in paragraph 3 or 4 above will cease to be eligible for the Scholarship.
- 6. Applicants must fill in the application form and submit hardcopies of it together with the following in hardcopies:
  - a) a personal statement describing the applicant's objectives, aspirations, plans after graduation and particulars of their extra-curricular activities, including sports, and their level of community involvement (in not more than 1200 words);
  - b) a recent passport-size photograph;
  - c) a copy of the completed UCAS application form and COPA form;
  - d) certified copies of IGCSE or GCE 'O' Levels transcripts (if applicable) and IB transcripts (applicable to those who have completed the IB examinations); and
  - e) up to 2 reference letters from persons whom the applicant has interacted with in the last two years. The referee should be someone whom the applicant has interacted with in a professional capacity and includes persons whom the applicant has interacted with in the course of internships, competitions, voluntary work, employment and/or entrepreneurial ventures.
